

## Criteria and form for submission of questions in advance prior to the shareholders meeting

Shareholders can submit questions regarding the agenda of the 2022 Annual General Meeting of Shareholders and other important information of the Company in advance. The Company determines the criteria, methods of submission and the process of considering questions as follows:

1. **Qualifications of shareholders:** Being a shareholder of the Company, which has the right to attend the of the 2022 Annual General Meeting of Shareholders.
2. **Criteria for submitting questions before the date of shareholders' meeting**
  - ❖ The questions must be related to agenda of the 2022 Annual General Meeting of Shareholders or important information related to the Company.
  - ❖ Qualified shareholders under Clause 1. may submit a “Form for submission of questions in advance prior to the shareholders meeting” along with supporting documents (if any) to the Company Secretary within **Monday 11 April 2022** via the following communication channels:

However, if it is a question that does not meet the specified criteria or is a question submitted beyond the specified period, the Company will assume that shareholders do not exercise the right to submit questions in advance.
